# of the Joint Committee Meeting on Road Transport between Turkey and Bosnia and Herzegovina

In accordance with the Agreement on International Transport of Passengers and Goods by Road signed between Turkey and Bosnia and Herzegovina on 20<sup>th</sup> May 2015, Joint Committee Meeting on Road Transport between Turkey and Bosnia and Herzegovina was held on 26<sup>th</sup> April 2018 in Ankara.

The delegations are listed in the appendix.

The Delegations discussed the issues concerning transport of goods and passengers by road between two countries based on the following items of the agenda:

- 1- Exchange of statistical information,
- 2- Goods transport,
- 3- Passenger transport,
- 4- Other issues

### 1- Exchange of Statistical Information

The Delegations exchanged statistical information regarding the trade volume and current situation of road transport between two countries.

The Delegations confirmed the compliance of statistical information with each other and expressed their satisfaction over the increasing trade and transport operations between the two countries. The Delegations agreed to exert necessary efforts in order to further increase trade volume between two countries.

#### 2- Goods Transport

The Delegations agreed to cooperate in order to further develop trade and facilitate goods transport between two countries.

Following the negotiations, the delegations agreed to exchange the final quota of 2018 and preliminary quota of 2019 as follows:

300 permits for transport operations to/from third countries

150 permits for unloaded entry/ taking load

The Delegations agreed that any demand for additional permits during the course of the year will be evaluated in goodwill.

Both Delegations agreed that the permits shall be valid until 31st January of the following year.





# 3- Passenger Transport

The Delegations exchanged information concerning passenger transport between two countries and expressed with satisfaction that passenger transport operations are carried out without any problem.

The Delegations also noted the importance of continuing current cooperation in order to further develop passenger transport by road between two countries.
